Executive Director's Report

It is with a sense of humble pride and awe that I write this, my first annual report as Executive Director of Children First. It hardly seems possible that nearly a year has passed since I arrived here August 30th in 2004 to take on the daunting responsibilities of my new position. I feel privileged to follow Dr. Lois Dobson - founding director, former colleague and personal friend - after her distinguished career leading the agency to where it is today.

What a year it has been! The beautiful "Welcome Breakfast" the staff prepared for me my first day on the job still brings a smile to my face. And from that moment on, we've immersed ourselves in one challenge after another, always with a view to moving forward in small steps or in leaps and bounds, depending on the tempo that was played for us, and always with an eye to the reason we are all here - to respond to the needs of children and families.

Between April 1, 2004 and March 31st, 2005 our staff has grown to 74 and we have served 1,026 families. I have to say it is a pleasure working with our staff of professionals who are so devoted to our families. I am impressed by their commitment and expertise, and especially by their advocacy that has brought issues to my attention and provided opportunities for us to work together within the agency and also with our community partners to make services work better for children with special needs. I appreciate all their support and patience in my learning curve as one of the newest members of Children First. I am still in the process of getting to really know everyone and our recent re-location from two sites to our new office "home" is already helping with that.

The move to 3295 Quality Way represents the culmination of a great deal of effort on the part of many to bring together developmental and mental health services for children from birth to age six. During the past year, a tremendous amount of planning, organizing and negotiating went into the construction phase of this process as we worked to bring the design of leasehold improvements for the new space into reality. The result is office space that is brighter and more spacious and conducive to our work. There are now more space options for people to come together for training and for planning services, as well as for families to participate in assessments, observations, and group activities. The location offers excellent access to families and community partners. The facility also affords the potential for further expansion, should there be an opportunity for continued growth in service delivery to address wait lists and meet new demands for service. We look forward to continuing our positive partnership with our partners in Family Respite Services who are co-located with us and who provide services that are compatible with ours. We also look forward to welcoming yet unknown new partners to the third and fourth floors of 3295 Quality Way Place.

The Labelle building finally sold in January, 2005 and we celebrated with staff, Board and funders to mark this turning point that allowed us the funding necessary to move forward and complete the project. I am happy to report that, with the proceeds of the sale and with the support of our provincial and municipal funders, we were able to complete the project within budgetary parameters. Overall, the big move went smoothly with everyone doing their part, and now we are wrapping up a myriad of details. Throughout this process, front line service to our families was maintained and staff are to be commended for their efforts.

At the same time, we were involved in multiple other initiatives that required our attention. Some highlights include:

- * The redesign of our computer data system that merged two programs into one new and improved "Children First Information System" (CFIS).
- * The launch of our preparations for accreditation in anticipation of our site review in January, 2006.













- * New strategies to market our services in conjunction with our new address, i.e. new brochure, identification of translation needs, etc.
- * Revamping our family satisfaction survey and corresponding process for distribution and analysis to solicit meaningful feedback in the spirit of continuous improvement.
- * Participation in a wide variety of professional development, including staff presentations and public relations; training onsite to use the Autism Diagnostic Observation Schedule (ADOS); and two half-day sessions for all staff to support and reinforce our transdisciplinary model of family-centred service and to identify and discuss strengths and challenges in the delivery of our services.
- * Bringing a better balance in direct service demands for Resource Teachers through the recruitment of four new positions with an infusion of \$200,000 in fiscal child care funding related to community planning for a more coordinated service system, in conjunction with the anticipated federal "Best Start" initiative.
- * Introduction of a new partnership with Dr. Elizabeth Macklin, developmental pediatrician, to provide consulting services for families to augment services provided by our staff.

Through it all, our dedicated staff remained loyal to the agency with only a few changes due primarily to maternity leaves for four staff and two resignations due to a family move away from Windsor as well as the pursuit of educational goals. There has been more pressure than usual for staff to volunteer their time and energy to participate in a variety of internal committees and work groups, i.e. CFIS, accreditation, moving, fundraising, etc. and much progress has been realized as a result of their efforts and cheerful enthusiasm.

Board members have also been busy working on committees relative to the new building, fundraising and finance, as well as participating in sessions relative to Board Governance. I have appreciated all the support and encouragement I have received from the Board during the introduction to my position. It is evident that we have a Board that cares about the children with special needs in our community and the kind of service we provide to them. Changes are also underway for the Board with new members joining as long-time members are retiring from years of service.

So we are continuing to evolve as an agency - to change and grow as new issues and opportunities come our way. I am counting on all of us to welcome change as a necessary part of growth, so that we can continue to shape our services in ways that fulfill the mission, principals and values of Children First.



Parent Satisfaction

In 2004/05, 164 family satisfaction surveys were mailed to parents. 9 of these were returned undeliverable. Of the 155 remaining, 42 were returned completed, thus a return rate of 27%, which was higher than the previous year. Most of the surveys included comments that indicated their appreciation for and satisfaction with the services they received.
